The Department for Education (DfE) has launched a national programme to protect children at risk of exploitation in England. The programme will be led by a team of academics and experts and will bring together education, health, social care, the police and the voluntary sector. 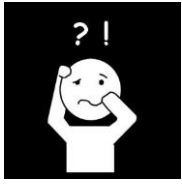

There is currently some work being carried out to identify who may be interested in becoming a Single Point of Contact (SPOC)

regarding **modern slavery**. To give you some idea of the responsibilities around this role here are some headlines -

#### **The Role of the Modern Slavery Single Point of Contact**

A Modern Slavery (SPOC) will be the allocated point of contact for cases of slavery and human trafficking within an organisation or department, where information is time-sensitive and accuracy is important.

#### **Role and Responsibilities**

- Completing a 2 hr training session on Modern Slavery and Human Trafficking including how the National Referral Mechanism (NRM) process works.
- Disseminating and sharing briefing documents and resources to colleagues/staff teams.
- Helping colleagues who may not routinely come across modern slavery recognise the signs and respond so that more victims get help and perpetrators are brought to justice.
- Guiding staff on how to complete an NRM referral or MS1, if they do not give consent when appropriate, where 'First Responder' duty applies.

- Providing information and guidance to staff on local support services and agencies within West Sussex who are actively involved in supporting victims.
