
Infant crying is the most common reason why parents seek help when they have a small baby. In extreme cases crying can cause problems in parenting and even trigger abuse. is taking place this year in **March** and in order to share key messages around

this topic with as many people as possible we are running 3 "Basic Awareness of Safer Sleeping Messages" sessions. These sessions will be delivered in partnership by a Named Safeguarding Nurse and the Lullaby Trust. Each session will be 2 hours long and are suitable for professionals who have not previously attended any similar training. Foster carers are also welcome to attend. 

Understanding the Needs of Children & Young People Who Present with Harmful Sexual Behaviour training is now available on the Learning and Development Gateway. This course, formally known as Children & Young People Who Sexually Harm provides delegates with the opportunity to explore different factors that may lead to a child or young person to engage in harmful sexual behaviours as well as strengths, needs and risk around this topic. We recently delivered our first **Working Together To Safeguard Children Refresher** training course and feedback from this has been really positive.

Those who attended said that they preferred a half-day session and felt that the content of the course was set at an appropriate level to those workers who already have a general knowledge of safeguarding and want to carry out more practice based work. This refresher covers tools and resources to support you in your safeguarding role, digital safeguarding as well as how to ensure referrals to MASH are of a good quality.
